## INSTRUCTION TO BIDDERS

1. Bids will be evaluated on scoring basis of each lot as per Annexure "A".  
The requirements for Tender for furniture and subscription i.e online Library/Pakistan law site and high-speed internet, only S. Nos 1,2,7,9 and 14 of Annexure A shall be followed. The requirement of Tender for the remaining items shall be the same as mentioned in the bidding documents of Annexure A. The Technical Bids must include.
  - i. Valid income tax and sale tax registration (Active Status).
  - ii. Affidavit of non blacklisting.
  - iii. Authorization letter from manufacturer (for Machinery and I.T).
  - iv. Proof of similar contracts executed in the last three years in Government Institution/Departments.
  - v. Details of Technical Staff.
2. The bidders must submit the proposals through EPADs and as per specified procurement method Single Stage Two Envelops Process.
3. The proposals must contain a transmittal letter on the bidder's letterhead, duly stamped.
4. The Financial proposal should be on the name address and contact details of the addressees and the addressors.
5. The proposal shall contain sales tax registration certificate.
6. Bidders may associate with other organizations to enhance their capacity; however, such associations may only take place before the bidding. Once firms are short listed, no such association will be allowed.
7. Collusion between the firms is strictly prohibited. Any firm / group of firms found involved in creating a cartel or any other collusion arrangement against the interest of the project/government, will be blacklisted and debarred.
8. The proposals should be in accordance with specification(s).
9. Response time: all bidders shall submit proposals till closing date and time. No proposal in any case shall be accepted after the deadline.
10. The bidder shall submit an affidavit that he/she has never been blacklisted under any of the provision of this Act or any other law in respect of or relating to public procurement, including any rules, regulations, orders or instructions made in this behalf and for the time being in force.
11. The bidder must quote all items in a Lot failing of any single item quoted will lead to disqualification of bid.

12. The Supplier shall deposit with the Procuring Entity a bid security @ 2 % of each item/full lot in the shape of CDR. The proof of CDR must be placed in financial proposal and the original will be deposited with Procuring Entity. A certificate stating "Bid Security included must be placed in the technical proposal".
13. The bid security money so deposited shall be returned after signing the contract (s).
14. The procuring entity may reject one or all such proposals, which are unclear or does not adhere to these instructions.
15. Successful bidders must furnish a 10% Performance Bank Guarantee, valid throughout the contract, which can be forfeited if the supplier fails to deliver goods as per terms and conditions. This bank guarantee should be from a scheduled bank.
16. Contract will be signed with the successful bidders and its terms and conditions will govern the executive of the contract.
17. Arbitration as per law will be in case of disagreement arising out of contract execution, which cannot be settled, between the two parties (procuring entity and supplier/vendor/bidder).
18. The goods will be inspected by the committee at Judicial Complex, Charsadda.
19. Payment will be made upon production of signed invoice, authenticated sales tax invoice, and other required documents, with applicable taxes deducted at source and satisfactory inspection by the committee.
20. If the supplier fails to deliver goods as per contract, the procuring entity can recover damages, purchase from another source, cancel the contract, or take other actions.
21. Disputes will be settled by the Grievance Redressal Committee mechanism as per section 35 of KPPRA Act 2012 and Grievance Redressal Rules 2017.
22. The supplier will indemnify the procuring entity against claims for infringement of patent, design, or trademark rights.
23. The supplier can't sub-let or assigns the contract without written permission from the procuring entity.
24. Neither party will be liable for obligations suspended due to events beyond their control, such as natural disasters or wars.

25. The agreement will be governed by KPPRA Act 2012 and KPPRA Rules 2014.


26. Notices must be in writing and delivered in person or through registered mail to designated addresses.


