

Their appointment to the service shall be subject to the following terms and conditions:

- i. They shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Government Servants (Appointment, Promotion & Transfer) Rules 1989.
- ii. They shall be allowed the minimum pay of BPS-03 plus other allowances as admissible under the rules.
- iii. They shall be governed by such rules and instructions relating to leave, T.A, and Medical Attendance as may be prescribed from time to time.
- iv. They shall be on probation initially for a period of one year extendable up to two years.
- v. Their services shall be liable to be dispensed with at any time without notice and assigning any reason before the expiry of the period of the probation if their conduct during this period is not found satisfactory. In the event of resignation from service, fourteen days' prior notice is required; failing which one month pay shall be forfeited to the Government. The resignation shall, however, be subject to the acceptance by the Competent Authority.
- vi. They shall be governed by the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 and the Khyber Pakhtunkhwa Government Servants Conduct Rules, 1987 and any other

instructions which are issued by the Competent Authority from time to time.

- vii. If the above terms and conditions of appointment are acceptable to them, they should report for duty to the undersigned immediately. The offer of appointment shall be deemed to have been cancelled if they fail to report for duty to the undersigned within one month from the date of issuance of this order.
- viii. They shall join duty at their own expenses.
